Fire Inspections- Six fire inspections were completed. Worked with Hillsman construction to finalize the Cinema way project and Griffin Drive project. Two driveway meetings were completed. Working on Site plan reviews for Motion Flow and Selmet.

Equipment- E-71 was involved in an MVC. The steering brackets were repositioned, and a new alignment was completed. The light rescue committee met with Hughes Fire and started the build process for the light rescue.

Training-

I had a phone meeting with the National Register of EMT's to get set up as the training officer for their system.

5 personnel completed the Nozzle Forward Class.

Working on getting Fire Rescue 1 academy (Lexipol) set-up.

Working on getting Cordico (Lexipol) set-up. This is Mainly for mental and emotional wellbeing, but also captures physical fitness, nutrition, financial, etc. app. Also has vetted therapists, videos on physical therapy and peer support. One hundred percent confidential. Admin will be able to see the number of people using it, not who is using the app. We have signed up for it for one year at \$999. Spouses are included. Out logo will be on the front page of the app. We will be the first ire department in Oregon to use this. The Board agreed this sounds like a good thing for our people.

Changing RMS to Lexipol. Better system and tracking. The board can also have access to this for their Law Classes.

Total Personnel Training Hours: **495.5** (Blue card included) 40 hours per person. Two are still working on completing it. Blue Card – mostly for structure fires.

Blue Card is now NIMS compliant. This is for tangent and other departments to speak on the radio and communicate better, speak the same language.

V. ACTIVITY REPORT:

Total YTD calls are 111. This is a decrease of 14 calls from 2023, decrease of 4 from 2022, increase of 20 from 2021 and up 19 calls from last month.

VII. NEW BUSINESS:

A. Midway & Three Lakes Road Accident – Griffin

AC Chapin explained E71 was staged outside a structure fire as E13 was on scene first. E71 was released. E71 was turning left onto Three Lakes Road from Midway when the engine was hit by a car. Dispatch contacted AC Chapin informing him of the accident. E71 crew handled it as per protocol. AC Chapin arrived at the scene. Parents of the other driver arrived on scene. Even though the car was blocking the train tracks, nothing was moved until law enforcement were on scene. Law enforcement arrived and followed their protocol. The driver of the car was taken to the hospital POD. Our volunteer followed protocol for involvement in a motor vehicle accident.

Chief Griffin, SDAO Risk Management and our insurance company were notified. E71 would be evaluated for any damage, not much can be seen.
